

❖ How to Make a Deposit

Deposits to Otet Markets are denominated in USD and can be made using the following cryptocurrencies:

- USDT-TRX (Tether on the Tron network)
- USDT-ETH (Tether on the Ethereum network)
- Bitcoin
- ❖ USDT-BSC (Tether on the Binance Smart Chain)
- ❖ TRX (Tron)

Otet Markets accepts USD deposits via various cryptocurrencies, including USDT-TRX, USDT-ETH, Bitcoin, USDT-BSC, and TRX.

We recommend using USDT-TRC20 to save on fees and get your deposit in faster.

At Otet, while deposits do not require verification, withdrawals necessitate the completion of the KYC process.


1.To make a deposit, please follow these steps in order:

On the homepage of the website (www.OtetMarkets.com), click on the 'Login' option.



2.On the login page, enter your email address and password, then click on the 'Login' button.






3. After logging into your account, click on 'Funds' from the left-hand menu.




4. In the menu that opens, click on the 'Deposit' button, then select your desired trading account and blockchain network.






5. In the Crypto Deposit section, select the specific cryptocurrency you wish to deposit. In the Payment Method, 'Indicative amount' section, choose the desired amount of cryptocurrency.



In the 'Amount to pay' section, you can view the dollar equivalent of the cryptocurrency you have selected.




*Note: If you select Bitcoin as your cryptocurrency, you will see both Legacy and SegWit addresses. These two address types are common in the Bitcoin network and differ in terms of format and functionality. SegWit addresses generally incur lower transaction fees compared to Legacy addresses.

6.In the next section, please review the payment details and click the 'Proceed' button.






7. At this stage, a new section will open displaying your wallet address. This address will be presented in both text format and as a QR code. You can copy the provided code and paste it into your digital wallet. Alternatively, you can scan the QR code using the 'Send funds' function within your wallet application to complete the deposit process.



8. Simultaneously, you will receive a confirmation email from our system notifying you of the successful deposit.





9. After making a deposit or withdrawal, you can check your balance by clicking on the 'OtetMarkets' option in the right-hand menu. On the homepage, you will see your account balance in USD. Your latest transaction history will be displayed in the 'Last Transactions' section.



Transfers from your personal wallet to your Otet account are processed instantly. However, if the deposit is made through an exchange or other methods, the transfer process may take some time. The waiting time depends on the rules and regulations of your originating exchange.




Fiat Deposit Section

The Fiat Deposit section is related to the brokerage's fiat currency payments and is under continuous development.


1. Currently, users from South Africa, Ghana, Nigeria, and Kenya can easily make deposits and withdrawals in their local currencies directly through Otet, without the need for intermediaries. To do this, simply select your preferred payment method from the 'Select Method' section



2. In the 'Select Group Currency' section, simply choose the desired currency from the available options




3. In the 'Indicative amount' section, you can input your desired currency and see its equivalent value in US dollars.



4. After verifying your information, click the 'Proceed' button to be redirected to the bank's payment page




