

How to Make a Deposit

Deposits to Otet Markets are denominated in USD and can be made using the following cryptocurrencies:

- USDT-TRC20 (Tether on TRON network)
- USDT-ERC20 (Tether on Ethereum network)
- BITCOIN (Bitcoin)
- USDC-BSC (USD Coin on Binance Smart Chain)
- TRX (TRON)
- MasterCard
- Visa Card

At Otet, while deposits do not require verification, withdrawals necessitate the completion of the KYC process.

Deposit via Cryptocurrencies

1.To make a deposit, please follow these steps in order:

On the homepage of the website (<u>https://otetmarkets.com/</u>), click on the 'Login' option.



2.On the login page, enter your email address and password, then click on the 'Login' button.

3. After logging into your account, click on 'Funds' from the left-hand menu.



4. In the menu that opens, click on the 'Deposit' button, then select your desired trading account and blockchain network.

*Note: If you select Bitcoin as your cryptocurrency, you will see both Legacy and SegWit addresses. These two address types are common in the Bitcoin network and differ in terms of format and functionality. SegWit addresses generally incur lower transaction fees compared to Legacy addresses.

In the **To Pay** and **To Get** sections, you can see the deposit amount and its equivalent in USD, respectively.

6. In the next step, after selecting your desired amount and viewing its equivalent, click the Send Request button to display the wallet address for the deposit. Make sure to choose the correct network.

You can copy the provided code and paste it into your digital wallet. Alternatively, you can scan the QR code using the 'Send funds' function within your wallet application to complete the deposit process.

9. After making a deposit or withdrawal, you can check your balance by clicking on the 'OtetMarkets' option in the right-hand menu. On the homepage, you will see your account balance in USD. Your latest transaction history will be displayed in the 'Last Transactions' section.





Transfers from your personal wallet to your Otet account are processed instantly. However, if the deposit is made through an exchange or other methods, the transfer process may take some time. The waiting time depends on the rules and regulations of your originating exchange.





Deposit via MasterCard and Visa Card

International Users

International users can currently make deposits to Otet Brokerage via Visa Card and MasterCard. To do so, please follow these steps:

1. On the main dashboard page, select **Funds** from the menu and click on **Deposit**. After choosing your desired account, click on **USD** in the **Currency** section.

After entering your card details, please do not close the page. Wait for the process to complete, and you will be automatically redirected to your dashboard.

Guide to Using Visa and MasterCard Payment Gateways:

- Access to the payment gateway is only available to users who have completed the KYC verification process and are using a bank card in their own name.
- Deposit processing may take up to 24 business hours. The minimum transaction amount is \$5 and the maximum is \$3,000. A 6.5% currency conversion and processing fee is automatically applied.
- Refunds are only issued for unused funds or failed transactions, and only after review by the finance team.
- Card information is not stored, and all transactions are processed on a secure platform in compliance with international standards.
- Transactions (deposits and withdrawals) via Visa and MasterCard are not available to customers from countries under international sanctions, including: Iran, North Korea, Syria, Sudan, Yemen, Cuba, Russia, Belarus, Afghanistan, Central African Republic, Congo, Somalia, Lebanon, Venezuela, and Iraq. Also Visa and MasterCard services are not available to users from countries with regulatory restrictions on brokers, such as the USA, Canada, and Turkey (this restriction applies only to citizens of these countries. Users with dual citizenship from other countries may still use banking services).

1. Currently, users from South African countries, including Ghana, Nigeria, and Kenya, can easily make deposits and withdrawals on Otet using their local currencies without intermediaries. To do so, simply select your preferred payment method from the Currency section.
