

## ✤ Withdrawal training

To withdraw funds from your user account, follow the steps below in order:

**1.** After logging into your user account, select 'Funds' from the left menu, and in the opened menu, click on 'Withdraw'.

**2.** Note: in order to withdraw funds from the account, you must complete the KYC process, which is done only once. Otherwise, you will not be allowed to withdraw money, and you will see the message shown in the image below.

**3.** After these steps, when you click on the 'Withdraw' button, the page you see in the image below will open, and you can choose the withdrawal amount, the cryptocurrency type, and the desired blockchain network.

**4.** Enter the withdrawal amount in USD in the 'Source amount' section. The equivalent cryptocurrency value will be displayed in the box in front of the 'Payment amount' section.

**5.** In the 'Method' section, you can check the cryptocurrency type and blockchain network to ensure you have selected the desired currency network. For instance, make sure you haven't accidentally clicked on 'Tether' under the Ethereum (ERC20) or Bitcoin (BTC) network instead of 'Tether' under the Tron (TRC20) network. The 'Fee' is also the amount of commission deducted during the withdrawal process.

**6.** In the next step, after confirming the accuracy of the input amount and cryptocurrency type, you need to enter the desired wallet address in the 'Wallet address' section.

\* Note: Keep in mind that once you enter the wallet address, you can save it within your Otet user account. By ticking the Save Details option (as shown in the picture above), the wallet address will be stored. With this feature, for future transactions, you can simply choose your preferred wallet from the Saved Withdrawals section, eliminating the need to re-enter the address.

In the profile section of your user account, there is an option called 'Whitelist' that allows you to manage various wallet addresses within your budget. The steps for this are explained in the tutorial on managing wallet addresses (<u>article link</u>).



\*Note: Please verify the accuracy of your saved wallet address. Otet Brokerage does not bear responsibility for any withdrawal issues resulting from incorrect address entries, as withdrawals from saved wallets are processed automatically.

**8.** After completing the above steps, press the 'Proceed' button to initiate the withdrawal request.

**1-9** Simultaneously, an email containing a PIN code will also be sent to you. Enter the code from this email into the designated box (as shown in the image above) and press the 'Confirm' button.

or Bitcoin blockchain network)
